Additional instructors:

Additional instructors have to fulfil the criteria for instructors of the relevant authorized outside agency and must be approved by the NANDTB Austria on request.

In case of a short-dated change of an instructor and an approval of the instructor is necessary the authorized outside agency has to inform the ÖNORM EN 4179/NAS 410 Level 3 examiner prior examinations to check and approve the instructor.

Documentation concerning skills and knowledge of the instructor must be provided by the authorized outside agency to the NANDTB Austria or in case of short-dated change to the Level 3 examiner.

Update:

The list of approved instructors list will be updated annually if necessary.

Training by the employer:

Instructors shall be designated or approved by the responsible Level 3 or by the NANDTB Austria on request.

All records will be maintained by the employer and shall be available for audit by customers, NANDTB and/or external agencies.
